# **Board of Education Meeting Minutes**

# 1. Meeting Called to Order by President

# 4. Consent Agenda

Burgess/Gehrke moved to approve the consent agenda items consisting of December 13, 2023 minutes, retirement of Patti Piotter-third grade teacher, resignation of Erin Maguire-District Social Worker, new hire of Denise LaFleur-Yancy-Middle School Special Education Teacher, December vouchers in the amount of \$1,467,516.65 and Treasurer's reports from July 2023 to November 2023. ### 9. Financial Update

Tricia Polakowski, Director of Business Services, informed the board that the 2022-2023 audit and financial statements have been completed and submitted to DPI. 2023-2024 actuals to budget figures were presented. The preliminary January membership count is down twenty-one students from the September count.

### 10. Superintendent Update

Dr. Durtschi talked about the staff advisory council meeting that took place this week for the first time. He explained that the district is considering a November Operating Referendum question. The timeline right now is to have Board approval in June.

Dr. Durtschi shared middle-of-the-year reflections: engaging new staff, the Communication Specialist position has been filled by Allison Gohlke, working on mailings going to all stakeholders, moving the Focus program to the previous district office, reducing property taxes and still being able to prepay debt, new math curriculum at the middle school and other new classes, took over the aquatics program from the City of Berlin, new musical instruments have been updated using ESSER funds.

Shout-outs to the coaches working with our students. The first year of a full-day 4K program. Shout out to Ms. Piotter for her years of valued service.
